## Bank Draft Authorization Agreement

### Authorization Agreement

I hereby authorize **Brown County Water Utility, Inc.** to initiate debit entries and to initiate, if necessary, credit entries and adjustments for debit entries in error to my (our) **Check only one**: \_\_\_\_\_ **Checking** or \_\_\_\_\_ **Savings** account indicated below and the financial institution named below, hereinafter called "Depository", to debit and/or credit the same to such account.

Expect a (1) billing cycle delay to set up your bank draft payment processing. Once initiated, you will receive a bill with the notation "**Bank Draft – Do Not Pay**" with the amount to be deducted for your total bill. **Your account will be drafted no earlier than the 15<sup>th</sup> day of each month.**

This agreement will remain in effect until **Brown County Water Utility, Inc.** receives a written notice of cancellation from me or my financial institution, or until I submit a New Bank Draft Authorization Agreement form to the Utility.
